Extract from Constitution & Rules of SIAE
Rule 7 – Rights & Privileges

- (1) **Honorary Fellows** - Such members shall have all the rights and privileges of membership including:
 - (a) the right to speak at all general meetings of the Institute;
 - (b) the right to stand for election to the Executive Committee, nominate or second an applicant, for election and to vote at all general meetings.
- (2) **Fellows/Ordinary Members** - Such members shall have all the rights and privileges of membership including:
 - (a) the right to speak at all general meetings of the Institute;
 - (b) the right to stand for election to the Executive Committee, nominate or second an applicant, for election and to vote at all general meetings.
- (3) **Associate Fellows** - Such members shall have all the rights and privileges of membership, including the right to vote at all general meetings, but excluding the right to stand for election to the Executive Committee.
- (4) **Associate Members** – Such members shall have all the rights and privileges of membership, including the right to vote at all general meetings, but excluding :
 - (a) the right to stand for election to the Executive Committee; or
 - (b) the right to nominate or second an applicant for election to membership.
- (5) **Corporate Members** – Such members shall have all the rights and privileges of membership, including:
 - (a) the right to be represented by two (2) nominees at any general meeting;
 - (b) the right to one (1) vote only at any general meeting but excluding:
 - (c) the right to stand for election to the Executive Committee; or
 - (d) the right to nominate or second an applicant for election to membership.
- (6) **Technician Members** – Such members shall have all the rights and privileges of membership but excluding:
 - (a) the right to vote in any general meeting;
 - (b) the right to stand for election to the Executive Committee;
 - (c) the right to nominate or second an applicant for election to membership.
- (7) **Student Members** – Privileges of Student Members shall be determined by the Executive Committee. The privileges shall be made known to applicants at the time of application and to existing members at the time of subscription renewal.

Note: Clause 6.8

A Student Member shall cease to be a Student Member upon his being eligible for Ordinary or Associate Membership.
