



Guide To Membership Application

ENTRANCE FEE

An Entrance Fee of **\$30.00** and Subscription Fee are required for consideration. If the application is not accepted, the entrance fee and subscription fee will be refunded.

Applicants should submit the completed form with an entrance fee of \$30.00 and subscription fee, photocopies of academic qualifications and a passport size photograph.

The following paragraphs provide guidance on the selection of membership class in the application.

ORDINARY MEMBERS **Yearly Subscription Fee: \$60.00**

Ordinary membership shall be opened to any person falling under **any** of the following categories who:

- a) is a practising engineer holding an Aircraft Maintenance Engineers Licence issued by the Civil Aviation Authority of Singapore or its equivalent;
- b) possesses a recognised Science or Engineering Degree and is employed in the aerospace industry;
- c) possesses relevant tertiary academic qualifications and has at least one (1) year's experience in the field of airworthiness certification under the Singapore Air Navigation Order or the equivalent subsidiary legislation;
- d) has served in an aerospace company at management level for a period of at least two (2) years.

ASSOCIATE MEMBERS **Yearly Subscription Fee: \$60.00**

Associate membership shall be opened to any person falling under **any** of the following categories :

- a) any person who possesses a University degree and is employed in the aerospace industry;
- b) any person who holds an Aircraft Maintenance Engineer's Licence but does not practice in the capacity of an engineer.
- c) any person who possesses a recognised Technician Diploma and has at least five (5) years' experience in the aerospace industry;
- d) any person who has passed the prescribed examinations conducted by the institute;
- e) any person holding a responsible position in an aerospace related organisation and who is desirous of furthering the objectives of the Institute.

TECHNICIAN MEMBERS
Yearly Subscription Fee: \$30.00

Technician membership shall be opened to any person who possesses a Certificate in Aircraft Maintenance Engineering or equivalent.

STUDENT MEMBERS
Yearly Subscription Fee: \$24.00 (wef 1 Jan 2008)

Student membership shall be opened to any person undergoing an approved training scheme that leads to the attainment of a qualification that satisfies the ordinary or technician membership criteria stipulated by the Institute.

FELLOWS
Yearly Subscription Fee: \$100.00

Ordinary Members who have:

- a) at least ten (10) years of continuous membership in the Institute or its predecessor membership and;
- b) have attained the age of thirty-five (35) years and;
- c) have contributed towards the objectives of the Institute.

ASSOCIATE FELLOWS
Yearly Subscription Fee: \$75.00

For persons who are:

- a) Teaching professionals and renowned academicians from the institutions of higher learning including tertiary institutions situated in or outside Singapore or;
- b) Senior management staff from aerospace companies who have made substantial contributions to the aerospace industry.

LIFE MEMBERS
One-time Subscription Fee: \$100.00

A member is eligible to apply to become a "Life Member" in his existing membership class provided:

- a) The member is at least 60 years of age;
- b) The member must have been a member for more than ten years preceeding his/her application; and
- c) The member must be retired and not in full time employment.

CORPORATE MEMBERS
Yearly Subscription Fee: \$500.00

Corporate membership shall be opened to aerospace organisations or related business registered in or outside Singapore who support the objectives of the Institute.

HONORARY FELLOW

- a) On the recommendation of the Executive Committee, Honorary Fellows may be elected at any general meeting of the Institute over and above the complement of Fellows and Ordinary Members.
- b) Majority two-third of the members to be present and voting shall be necessary to ensure election.
- c) Hon. Fellows should not be required to pay any entrance or subscription fee.

Each applicant and the prescribed one-time fee to be made from time to time will be subjected to the approval of the Executive Committee.
