Before returning to Singapore, Jeremy Chan was Executive Vice Chairman of Mubadala Aerospace MRO network from November 2011 to April 2013. Based in Abu Dhabi, he was part of a global leadership team that led the integration of ADAT and SR Technics, based in Zurich. In this role, Jeremy focused on the strategic directions and longer term business sustainability of the Group. Prior to this, Jeremy was Chief Executive Officer of Abu Dhabi Aircraft Technologies (ADAT) from March 2010 to December 2011. ADAT is a wholly-owned subsidiary of Mubadala Development Company, the strategic investment arm of the Government of Abu Dhabi. At ADAT, Jeremy drove the company's ambitious growth strategy and strengthened its position as the foremost independent technical services provider in the Middle East, whilst strengthening the company's partnership with sister entity SR Technics, to cater to the global MRO marketplace.

Jeremy has more than 25 years of extensive experience. He began his career with the Singapore Economic Development Board where for 9 years he helped in developing and promoting the local aerospace industry.

In 1994, Jeremy became Managing Director of Turbine Overhaul Services, a Joint Venture between Pratt & Whitney (P&W) and ST Aerospace where he established the company as a global Centre of Excellence for the repair of P&W's turbine airfoils.

Jeremy joined Honeywell in 1998. He became Vice President of Aviation Aftermarket Services (Asia Pacific) as well as General Manager of Honeywell Singapore, following the merger of Allied Signal and Honeywell in January 2000. He led Honeywell Aerospace's repair and overhaul facilities (for both avionics and mechanical components) in Singapore, Malaysia, China and Australia. He was also named the Managing Director of Honeywell ESA manufacturing facility in Singapore. In 2005, he became Vice President, Airlines of Air Transport & Regional, (Asia Pacific).

Jeremy was Deputy President (Marketing & Total Aviation Support) of ST Aerospace, the aerospace arm of the public-listed ST Engineering from August 2006 to March 2010. Jeremy steered the marketing and oversaw the expansion into Total Aviation Support business, investments and joint ventures. In addition, he managed the growth of STA's Component and Engine Total Support business segments.

Jeremy graduated with a First Class Honors degree in Aeronautical Engineering from Manchester University, UK in 1981. He was conferred with the Master of Science in Management (a Sloan Fellow) from Stanford University, USA in 1994.
